## DECISION

## ON PROVISION OF CATERING SERVICES IN PRE-PRIMARY AND PRE-SCHOOL GROUPS OF EDUCATIONAL INSTITUTIONS ESTABLISHED BY KAUNAS CITY MUNICIPALITY

Pursuant to Articles 6(4) and 16(2)(37) of the Law on Local Self-Government of the Republic of Lithuania, Article 36(8) and (9) and Article 60(1)(15) of the Law on Education of the Republic of Lithuania, clause 8 of Lithuanian Hygiene Standard HN 75:2016 "General health safety requirements for the implementation of pre-primary and pre-school education programmes" approved by Order No V-313 of the Minister for Health of the Republic of Lithuania of 22 April 2010 approving the Lithuanian Hygiene Standard HN 75:2016 "General health safety requirements for the implementation of pre-primary and pre-school education programmes", sub-clauses 32.1 and 32.2 of the Description of the procedure for organizing children catering approved by Order No V-964 of the Minister of Health of the Republic of Lithuania of 11 November 2011 On Approval of the Description of the Procedure for Organizing Catering in Pre-school Education, General Education Schools and Child Social Care Institutions, Article 5(3) of the Law on Social Assistance of the Republic of Lithuania, the Council of Kaunas City Municipality decides as follows:

1. To approve the fee for pre-primary and pre-school children catering services (daily meal rates) of educational institutions established by Kaunas City Municipality for each day attended by the child and unjustifiably not attended:

1.1. For a child of the nursery-kindergarten group: breakfast – EUR 0.48, lunch – EUR 0.85, afternoon meal – EUR 0.25, dinner – EUR 0.48, pre-night meal – EUR 0.2;

1.2. For a child of kindergarten group: breakfast – EUR 0.52, lunch – EUR 0,98, afternoon meal – EUR 0.3, dinner – EUR 0.52, pre-night meal – EUR 0.2;

1.3. For a child of the pre-school group: breakfast – EUR 0.52, afternoon meal – EUR 0.3, dinner – EUR 0.52, pre-night meal – EUR 0.2.

2. To allow the directors of the educational establishments referred to in clause 1, with the approval of the councils of these establishments, to determine the number of child meals according to the duration of the activities of the groups of the establishment.

3. To allow parents of children who have made a written request to the directors of the educational establishments referred to in clause 1 to:

3.1. Choose the number of meals for at least one month and pay a fee according to how many hours a day the children spend in the establishment, provided that the children are fed every 3.5 hours;

3.2. Refuse catering services if children spend no more than 4 hours per day in the educational institution.

4. 4. To set the following fee per lunch for the employees of the educational establishments referred to in clause 1, who wish to have lunch - EUR 1.16.

5. Repeal Decision No <u>T-350</u> "On the provision of catering services in pre-primary and pre-school groups of educational establishments established by Kaunas City Municipality" with all amendments and supplements of Council of Kaunas City Municipality of 9 July 2010.

6. This Decision shall enter into force on 1 September 2020.
